THURSDAY, SEPTEMBER 10, 2020**

- 1. Call to Order** – City Clerk Haug called the meeting to order at 4:02 p.m.
- 2. Roll Call** – Commissioners Mark Hanneman, Greg McDowell, Robert Perkes and Luis Ojeda were present. City Clerk Stephanie Haug and City Attorney Bronson Brown were also present.
- 3. Designate Chairperson and Vice Chairperson** –  
*Commissioner McDowell moved to designate Mark Hanneman as Chairperson, seconded by Commissioner Ojeda. The motion carried unanimously.*  
  
*Commissioner Ojeda moved to designate Greg McDowell as Vice Chairperson, seconded by Commissioner Perkes. The motion carried unanimously.*
- 4. Approval of Agenda** – *Commissioner McDowell moved to approve the agenda as presented, seconded by Commissioner Hanneman. The motion carried unanimously.*
- 5. Approval of Minutes of Salary Commission Meeting of October 18, 2018-**  
*Commissioner Perkes moved to approve the minutes of October 18, 2018, seconded by Councilmember Hanneman. The motion carried unanimously.*
- 6. Review By City Attorney-**
  - a) City of West Richland Form of Government- City Attorney Brown explained the city's Mayor Council government in comparison to Council Manager. He also pointed out the roles of Mayor and Council Members.
  - b) Ordinance Creating Salary Commission – City Attorney Brown provided an overview of the ordinance that created the City of West Richland Salary Commission. He pointed out that a public hearing is required before setting a new salary schedule.
- 7. Role of Mayor and City Council Members**  
City Attorney Brown reviewed the general roles of the Mayor and the City Council. The City of West Richland does not have a City Administrator so the Mayor is filling that role.
