SALARY COMMISSION MEETING
THURSDAY, SEPTEMBER 17, 2020**

- 1. Call to Order** - Chairperson Hanneman called the meeting to order at 3:31 p.m.
- 2. Roll Call** – Chairperson Mark Hanneman, Vice-Chairperson Greg McDowell, Commissioner Robert Perkes and Commissioner Luis Ojeda were present. City Clerk Stephanie Haug and City Attorney Bronson Brown were also present.
- 3. Approval of Agenda** – *Commissioner Ojeda moved to approve the agenda as presented, seconded by Vice-Chairperson McDowell. The motion carried unanimously.*
- 4. Approval of Minutes of Salary Commission Meeting of September 10, 2020-**
Commissioner Ojeda moved to approve the minutes of September 10, 2020, seconded by Vice-Chairperson McDowell. The motion carried unanimously.
- 5. Review By City Attorney-**
City Attorney Brown reviewed the information previously provided to the Salary Commissioners and asked if anyone had any questions. There were none.
- 6. Discussion on Data Provided at September 10th Meeting-** No additional information was requested.
- 7. Recommended Rates by Commissioners-**
Chairperson Hanneman asked for Commission input on proposed rates.

Vice-Chairperson McDowell said that the positions are due for a raise. He had reviewed the CPI and feels like it's lagging a bit, and if anyone has gone shopping recently, they would agree.

Commissioner Ojeda feels that the positions are valuable and should be compensated as such.

Commissioner Perkes had concerns about the appearance of giving raises during the COVID pandemic.

Chairperson Hanneman thinks that West Richland is lagging behind what other cities are paying and feels that the positions are due for a raise, assuming the current condition of the City can afford to give them.

Commissioner Perkes asked about quantifying the impacts to the City. He is hopeful that with the number of Hanford/federal employees living within the City that there wasn't too much loss of income to the citizens, and there won't be a negative perception with raises. He indicated he is not opposed to giving them.

Commissioner Ojeda suggested a 10-20% raise, raising the Mayor's salary without an Administrator to \$6,000 a month.

Commissioner Perkes proposed the following amounts: Mayor without Administrator- \$6000 a month, Mayor with Administrator - \$2500 a month, City Council - \$600 a month

Vice-Chairperson McDowell suggested: Mayor without Administrator- \$5800 a month, Mayor with Administrator - \$2500 a month, City Council - \$600 a month

Chairperson Hanneman suggested: Mayor without Administrator- \$6000 a month, Mayor with Administrator - \$2500 a month, City Council - \$600 a month

Vice-Chairperson McDowell moved to recommend the preliminary new salary amounts to be the following: Mayor without Administrator- \$6000 a month, Mayor with Administrator - \$2500 a month, City Council - \$600 a month. Commissioner Ojeda seconded the motion. The motion

passed with a unanimous vote.

A public hearing will be scheduled at the next meeting to receive public comment on the proposed changes.

8. Meeting Schedule –

The Commissioners will meet on October 1, 2020 at 4:00 p.m.

9. Adjournment-

Commission Ojeda moved and Vice Chair McDowell seconded to adjourn the meeting. The motion passed unanimously.


