



# UTILITY RATES (Effective June 22, 2023)

## WATER RATES\* (WRMC 13.56):

Service rates are based on the size of the water meter on your property and the amount of water consumed during the billing cycle. **Most residential customers have a 3/4" or 1" meter.** There is a base charge and a consumption charge. The consumption charge is per 100 gallons. For those outside of City limits receiving water services, there is an additional 50% surcharge on the base and consumption charges, resulting in a \$51.78 base charge and \$.285 consumption charge. The amount billed includes a utility tax of 13.5% on the gross revenue of the water utility for 2023.

## SEWER RATES (WRMC 13.26)\*\*:

Service rates are based on your class of customer (i.e. residential, commercial, etc.). There is a base charge for all customers. Commercial customers have a base charge plus consumption charge. For those outside of city limits receiving sewer services, there is an additional 50% surcharge on the base charge resulting in a \$74.34 base charge. The amount billed includes a utility tax of 13.5% on the gross revenue of the sewer utility for 2023.

## IRRIGATION RATES\* (WRMC 13.70):

Service rates are based on a variety of factors such as location and/or size of your lot. The rate is a base fee that is charged over the twelve months in a calendar year. Most customers fall within the "Residential" type of customer.

# UTILITY RATES (Effective June 22, 2023)

## **GARBAGE RATES\* (WRMC 8.04):**

Service rates are based on the size and number of disposal containers you have. Most residential customers have a 96 gallon can. Other fees can apply for requesting additional containers, special disposal needs or if there is excess garbage in a larger container (e.g. dumpster). The amount billed includes a utility tax of 8.5% on the gross revenue of the solid waste utility for 2023.

## **STORM WATER RATES\* (WRMC 13.80):**

Service rates are based on your class of customer (i.e. single family residential, commercial, etc.). The rate is a base charge and it is for the purpose of managing the City's storm water system. The amount billed includes a utility tax of 6% on the gross revenue of the storm water utility for 2023.
